





But thwarted by the relentless burden of fundraising and associated bureaucracy, growing demand for their services; juggling income generation with core mission and purpose and managing volunteer community

Community Partnerships with specialist, full time employees (gardening, volunteer engagement, fundraising, social work support

But thwarted by precarious, short term funding, increasing demand for their services, rocketing poverty and increasing burden of fundraising and associated bureaucracy
