#### **Martin Avila**



Martin is a champion of social enterprise and passionate about its ability to help strengthen our communities and tackle inequality. He was CEO of the CEIS Group, the UK largest and oldest social enterprise support organisation.

He was previously the Director at the Kinning Park Complex (KPC), a multi-use community venue in Glasgow with a track record of innovative partnership working and of supporting others to develop

new programmes of activity. Under his leadership the KPC conducted a flagship buyout of their centre, delivered a multi-million-pound renovation project and launched one of Scotland's first Local Place Plans.

He was previously a Board member of Community Land Scotland and SURF (Scotland's Regeneration Forum), Treasurer of the Alliance of European Voluntary Service Organisations and Chair of the Loesje International Foundation.

He currently sits on the Board of the Economic Development Association Scotland, the Expert Advisory Panel for SURF and the Innovation, Entrepreneurship and Engagement Directorate subgroup of the University of Glasgow Economic Development Board.

# Fiona McKenzie | Founder | CentreStage



After 20 years, Fiona left her career as a secondary school Principal Teacher of Music to found CentreStage in 2006.

CentreStage's vision to create a community where everyone can experience the joy of music, the arts and wellbeing and seamlessly access all they need to flourish in life has been being driven through the £5.2M regeneration of Scotland's largest community-led asset transfer to date, at the regenerated 1.8 hectare site of the former Kilmarnock Academy, where a diverse range of over 20 private, public and third sector organisations are now working together to create a fully integrated ecosystem of support and opportunity for all.

Fiona was awarded the OBE in the Kings First Birthday Honours List and was awarded the Honorary Degree of Doctor of Letters from Caledonian University. She is an Entrepreneurial Founder at the Hunter Centre for Entrepreneurship at Strathclyde Business School and is also privileged to have received the Paul Harris Fellowship from Rotary International; Association of Scottish Businesswomen Woman of Inspiration Award and Association of Scottish Businesswomen Outstanding Contribution Award. She currently serves as director of Ayrshire Chamber of Commerce and Industry and is recently elected Chair of the Kilmarnock Town Board, formed to deliver £20M levelling up funding to Kilmarnock over the next 10 years.
